#### 1. OPENING AND WELCOMING ADDRESSES

The second meeting of the Advisory Body of Experts on the Law of the Sea (IOC/ABE-LOS II) was opened on Monday 6 May 2002 at 09.30 by the Moroccan Minister of Higher Education, Training, and Scientific Research Honourable Mr Najib Zerouali Ouariti and by the Governor of the Province of El Jadida, Mr Mohammed Fassi-Fehri.

On behalf of his Government, Mr Najib Zerouali Ouariti welcomed the participants who came from afar to attend the IOC/ABE-LOS meeting in his country. He referred to the maritime tradition of his country, and emphasized the importance of the issue of transfer of marine technology, not only to his country, but also to other developing States facing increasing demands for action in the light of the evolving Law of the Sea.

The Assistant Director-General of UNESCO, Executive Secretary of IOC, Dr Patricio Bernal, thanked the host country for its welcome and noted that Morocco offers a good example of a State which has developed effective institutional, legal, scientific, and technical responses to the Law of the Sea. He praised the Moroccan participation in international initiatives such as GOOS-Africa and MedGOOS. He highlighted the establishment of the *Réseau National de la Recherche en Mer* (REMER) as an important step forward in accordance with UNCLOS Part XIV, Section 3, and with the guidelines issued by UN/OLA/DOALOS. He outlined the three themes to be discussed in the forthcoming sessions: Transfer of Marine Technology (TMT); IOC internal procedure for Marine Scientific Research (MSR) undertaken by or under the auspices of IOC; and the results of the collection and analysis of the IOC completed second questionnaire dealing with the practice of States in the fields of MSR and TMT.

Statements were also delivered by the President of the Municipal Council, the Rector of the University Chouaïb Doukkali, the Dean of the Faculty of Science, and Professor Mohammed Moncef, National Coordinator of the IOC/ABE-LOS II meeting for the Kingdom of Morocco.

#### 2. ADMINISTRATIVE ARRANGEMENTS

#### 2.1 DESIGNATION OF THE RAPPORTEUR

The Chairperson of IOC/ABE-LOS, Mr Elie Jarmache, proposed Mr Samuel Betah from Cameroon as Rapporteur, and the meeting accepted his proposal.

#### 2.2 ADOPTION OF THE AGENDA

The Agenda was reviewed and accepted with one amendment: the title of Item 3 was changed to "Review of Intersessional Activities".

#### 2.3 DOCUMENTATION

The Technical Secretary Ms Dienaba Beye presented the documents listed in IOC/ABE-LOS/II/4 prov, with three supplements:

- (i) UN/OLA/DOALOS Marine Scientific Research A Guide to the Implementation of the Relevant Provisions of UNCLOS;
- (ii) Oceans and law of the sea Material for the Report of the Secretary-General to the United Nations Open-ended Informal Consultative Process established by the

General Assembly in its Resolution 54/33 (ICP) in order to facilitate the annual review by the Assembly of developments in ocean affairs (Third Meeting, 8 to 15 April 2002);

(iii) Marine Science and Ocean Services for Development: UNESCO/IOC Comprehensive Plan for a Major Assistance Programme to enhance the Marine Science Capabilities of Developing Countries (IOC/INF-612).

The issue of delayed translations was raised by some delegates who expressed concern that the French versions of some documents were not delivered in time to permit review and consideration.

#### 2.4 CONDUCT OF THE SESSION

The IOC/ABE-LOS Chairman reminded delegates that the Year 2002 is the twentieth anniversary of UNCLOS, and he urged them to recall this milestone in their discussions, paying particular attention to the need for raising awareness among the younger generation of the significance of the Convention. The meeting agreed to follow the adopted agenda.

#### 3. REVIEW OF INTERSESSIONAL ACTIVITIES

# 3.1 CHAIRMAN'S REPORT ON IOC/ABE-LOS ACTIVITIES DURING THE INTERSESSIONAL PERIOD

In delivering his report (IOC/ABE-LOSII/6), Chairman Elie Jarmache highlighted the following:

- 1. Establishment of two Working Groups in accordance with Resolution XXI-2 adopted by the 21<sup>st</sup> Session of the IOC Assembly (Paris, 3-10 July 2001): one on the Transfer of Marine Technology (chaired by Mr Ariel Gonzalez, expert from Argentina) and the other on the IOC internal procedures related to an effective and appropriate use of Article 247 of UNCLOS (chaired by Professor Alfred Soons, expert from The Netherlands);
- 2. Conduct of a survey on States' practices in the fields of Marine Scientific Research (MSR) and Transfer of Marine Technology (TMT). He expressed thank to the IOC Secretariat, and in particular to Mr Roland Rogers of the United Kingdom, who was assigned to the Secretariat for analysing the results of the completed second questionnaire related to UNCLOS Part XIII and XIV.
- 3. Resolution A/RES/56/12 adopted by the UN General Assembly, where IOC/ABE-LOS was invited in paragraph 23 to work in close cooperation with UN/OLA/DOALOS on the development of procedures under Part XIII of the Convention.
- 4. The importance attached to the Transfer of Marine Technology and capacity building in marine sciences at the third session of the United Nations Open-ended Informal Consultative Process (ICP), as had been done in the two previous sessions.

Referring to document IOC/ABE-LOSII/inf.3, he raised the issue of the overlapping mandates of IOC/ABE-LOS and the I-GOOS "ad hoc Group of Experts on GOOS and UNCLOS", with consequent risk of a duplication of effort. The I-GOOS group had been established to consider preliminary scientific issues to be taken into account in establishing a legal framework that would apply to GOOS. He further pointed out that the I-GOOS group had been established as a unilateral

initiative and questioned the rationale for its existence when IOC/ABE-LOS has a specific mandate to advise IOC on UNCLOS-related matters.

Delegates made the following comments in response to the Chairman's report:

It was noted that IOC/ABE-LOS is gaining international recognition, as it is mentioned not only in the reports of the past two UN Informal Consultative Process sessions, but also at the higher level in the United Nations General Assembly (UNGA) Resolution A/Res/56/12.

It was suggested that the Chairman's report should have included a reference to paragraph 22 of Resolution A/RES/56/12, which also highlights the IOC role in the promotion of Marine Scientific Research. In this paragraph, the UN General Assembly:

"Calls upon States, through national and regional institutions, to ensure that, in respect of marine scientific research conducted pursuant to Part XIII of the Convention in areas over which the coastal State has jurisdiction, the rights of the coastal State under the Convention are respected and that, at the request of the coastal State, information, reports, results, conclusions and assessments of data, samples and research results are made available, and access to data and samples are provided, to that coastal State".

It was further expressed that paragraph 23 of the referred Resolution must be considered in conjunction with Paragraph 22.

Several delegates shared the IOC/ABE-LOS Chairman's concern over the unilateral establishment of the I-GOOS ad hoc Group of Experts on GOOS and UNCLOS, and several delegates expressed their reservations concerning the content of the Group's Report (IOC/ABE-LOSII/Inf.3), and its terminology. A number of delegates indicated that they would raise these issues at the 35<sup>th</sup> Session of the IOC Executive Council to be held in Paris in June 2002.

Dr Patricio Bernal, Executive Secretary of the IOC, recalled that IOC/ABE-LOS was established by Resolution XIX-19 of the IOC Assembly in July 1997. He pointed out that the Intergovernmental panel for GOOS (I-GOOS) has the authority to establish its own groups of experts, and that in this context, the ad hoc Group of Experts on GOOS and UNCLOS was established under the authority of the I-GOOS Chair. He also stated that the matter would be placed on the agenda of the 35<sup>th</sup> Session of the IOC Executive Council.

In further discussion the view was expressed that the issue at stake was not one of the authority of I-GOOS to establish an Expert Group but rather of the inefficiency of establishing an Expert Group in an area of competence of another IOC Subsidiary body, in this case IOC/ABE-LOS.

The representative of UN/OLA/DOALOS expressed some reservations concerning the content of IOC/ABE-LOSII/Inf.3, and indicated that there would be a more substantial response in due course.

#### 3.2 PROGRESS REPORT OF THE CHAIRMAN OF THE IOC/ABE-LOS SUB-GROUP ON THE DOCUMENT IOC/INF 1054 ON "DRAFT IOC PRINCIPLES ON TRANSFER OF MARINE TECHNOLOGY

The Chairman of the Sub-group, Mr Ariel Gonzalez, presented his Progress Report, included in Document IOC/ABE-LOSII/7. In particular, the following aspects were highlighted:

1. Mr Gonzalez recalled the basis of his mandate as contained in the first recommendation of Resolution XXI-2 adopted by the 21<sup>st</sup> Session of the IOC Assembly:

"That further work is required for the development of guidelines, criteria and standards on the transfer of marine technology, including capacity building related to marine scientific research (MSR), in accordance with Article 271 of UNCLOS on guidelines, criteria and standards, and other related provisions of Part XIV of UNCLOS. To this end, an openended Sub-group of IOC/ABE-LOS should be established to re-draft, by correspondence, the document IOC/INF-1054 on "Draft IOC Principles on transfer of marine technology", taking into account the debate on this issue at the first meeting of IOC/ABE-LOS. This Subgroup should operate in close co-operation with the Division of Ocean Affairs and the Law of the Sea, Office of Legal Affairs, United Nations Secretariat (UN/OLA/DOALOS)"

- 2. In this context, and taking into account the view of the first meeting of IOC/ABE-LOS (11-13 June 2001) that IOC/INF-1054 "*Draft IOC principles on transfer of marine technology*" was a good starting point, he had made an extensive redrafting of the document, in consultation with the members of the Sub-group. In this work, he was mainly guided by four objectives: (i) consistency with regard to UNCLOS –in particular, Part XIV; (ii) flexibility arising from the non-binding nature that the document should have; (iii) effectiveness in devising a mechanism whereby all States would benefit, on an equitable and reasonable basis, from TMT; and (iv) imagination in promoting TMT –in particular, through partnerships.
- 3. Before going into a detailed review of the draft document, he drew attention on the following general issues for discussion: the relationship between capacity-building and public awareness; the definition of marine technology; the purpose of TMT; potential restrictions; mechanisms for management; and a possible TMT Application Form (TMTA) of which he presented a preliminary text, for discussion.

Following this presentation, the Group reviewed the *draft Criteria and Guidelines* included in the document paragraph by paragraph. Delegates were in general satisfied with the contents of the draft, offering comments and suggestions for improvement. An important and recurring theme was the need for IOC to assume an active role in the overall TMT process, and to serve as a clearinghouse mechanism along the lines of the model established by the 1995 Washington Declaration on the Protection of the Marine Environment from Land-Based Activities and its Global Programme of Action.

Delegates also recognised the disparities among coastal States in terms of skills and capacities depending on their geographical location. Developing coastal States will need training, capacity building, know-how and equipment through TMT. IOC should, therefore, develop a substantial programme to support developing countries through TMT so as to reduce the gap that exists between them and the developed countries.

There was a discussion on whether TMT in this context should include the provision and transfer of legal marine expertise.

Some delegates expressed the views that item (h) of para. 2 of the draft Criteria and Guidelines, regarding legal assistance was entirely consistent with the chapeau providing that marine technology "refers to knowledge in all forms that would be useful to improve the study and understanding of the marine environment". In this regard, some of them suggested item (h) be redrafted to be more precise.

**The IOC/ABE-LOS Group approved** the following schedule for future work on this issue, as proposed by the Chairman of this Sub-Group: End of May 2002: submission by e-mail of a fourth draft of the Criteria and Guidelines, for comments by the members of the Sub-group.

- June 2002: sessional open-ended working group, in the framework of the 35<sup>th</sup> Session of the IOC Executive Council, to review progress made.
- September 2002 to March 2003: discussion by the members of the Sub-group, through e-mail, of a fifth –and possibly sixth draft of the Criteria and Guidelines.
- April/May 2003: examination and possible approval of the Criteria and Guidelines by the third IOC/ABE-LOS session (subject to approval by the IOC Executive Council of such a meeting)
- June/July 2003: possible adoption of the Criteria and Guidelines by the 22<sup>nd</sup> IOC Assembly.
- 3.3 PROGRESS REPORT OF THE CHAIRMAN OF THE IOC/ABE-LOS SUB-GROUP ON THE POSSIBLE ESTABLISHMENT OF AN IOC INTERNAL APPROPRIATE PROCEDURE RELATED TO AN EFFECTIVE USE OF ARTICLE 247 OF UNCLOS ON MARINE SCIENTIFIC RESEARCH PROJECTS UNDERTAKEN BY OR UNDER THE AUSPICES OF INTERNATIONAL ORGANIZATIONS

This item was introduced by Professor Alfred Soons, Chairman of the Sub-group. He made several general and specific comments. He recalled that his mandate was spelled out in the second recommendation of Resolution XXI-2 adopted by the 21<sup>st</sup> Session of the IOC Assembly. He went on to describe the procedure followed in the preparation of working document IOC/ABE-LOSII/8, outlining the two main criteria he had applied in drafting the text:

- 1. the end result should be a simplified and workable procedure for all parties involved in the execution of international marine scientific research projects, while safeguarding the rights of coastal States; and
- 2. the text should be short and clear, conforming closely to the text of UNCLOS, avoiding unnecessary repetition of UNCLOS provisions.

Turning to the document, he stated that he had shortened the title because he assumed the procedure in question, if adopted by the IOC Assembly, might lead to its consideration as an IOC internal procedure related to an effective and appropriate use of Article 247.

Paragraph 1 of the Draft restricted the procedure to MSR as governed by Part XIII of UNCLOS. It did not contain a definition of what constituted research "under the auspices" of IOC since that had to be decided by the IOC Assembly in individual cases.

He then expressed the view that paragraph 2 was the core element of the procedure for applying Article 247. It designated the Assembly as the competent organ. In view of the long-term planning often involved in international marine scientific research projects, and the fact that the Assembly only meets biennially, there is a need to accord some flexibility with respect to the required detailed description to be made available at the date of the adoption of the project by the Assembly. He suggested inclusion of the words "to the extent feasible at this stage". The Annex to the resolution could of course contain a mechanism to deal with this eventual. In this context, he also stressed that the use of Article 247 procedures would require close co-ordination between those representing their country at IOC meetings and the officials within coastal States administrations dealing with the handling and supervision of applications for consent.

Professor Soons identified additional issues in his draft that might need particular attention, such as the use of diplomatic channels versus possible alternative of appropriate official channels, the application of the procedure at the regional level (Paragraph 6), and the special case of non-IOC Member States (Paragraph 8).

Participants were then invited to make general statements concerning the draft.

With reference to Paragraph 6, the IOC Executive Secretary, Dr Bernal clarified the status of the IOC regional subsidiary bodies. He recalled that IOC has two sub-commissions, the IOC Sub-Commission for the Caribbean and Adjacent Regions (IOCARIBE) based in Cartagena de Indias, Colombia, and the Western Pacific (WESTPAC) based in Bangkok, Thailand, with their own permanent secretariats. Both are intergovernmental bodies, presided over by chairs elected by Member States. He referred to the four regional committees that do not have permanent UNESCO/IOC staff: IOCEA (eastern Atlantic), IOCINCWIO (western Indian ocean), IOCINDIO (Central Indian ocean), and the Black Sea Committee. He recognized the will to de-centralize the MSR process towards the regional committees, which would have financial implications for the Commission.

He also dwelt on the complexity of the planning and execution of major ship borne operations, and expressed the need for recognition of these realities in the drafting of this procedure under Article 247. He recalled that in the previous IOC Statutes, it was stated that IOC implemented its programmes through the concerted actions of its Member States. IOC/ABE-LOS should contribute to the definition of a procedure applicable especially to multilateral co-operative research projects that involve all coastal States members of IOC. By the multilateral character of these projects, developing coastal States would have the opportunity to be involved from the beginning of the planning phase.

Mr Abdulqawi Yussuf, Director of the Office of Legal Affairs of UNESCO, recalled the history of Parts XIII and XIV of UNCLOS. He provided a brief description of Article 247, and suggested that it would be counterproductive to concentrate on elucidating the Article itself in all possible contexts. Given that IOC is not the only international organization involved in MSR, IOC/ABE-LOS should focus on devising internal IOC procedures that would help IOC in the use of Article 247. With regard to the meaning of "internal procedure," he stated that it consisted of steps that would be undertaken within the IOC for the approval, notification, and implementation of a project.

Although the procedure might be internal to IOC, it would also affect the State or States referred to in Article 247 since certain actions or omissions by such States, with respect to the steps taken by IOC, would have consequences for them through the "deeming procedure" in the provisions of this Article.

Many important concerns and reservations were raised in a series of general and specific commentaries from the floor.

<u>**Title**</u> – there was no consensus on the proposal to shorten the title, with some delegates insisting that it reflects the wording of the recommendation adopted by IOC Assembly Resolution XXI-2; one delegate suggested the following title: "Rules of Procedures of MSR Projects undertaken under the auspices of IOC".

<u>**Terminology**</u> (Paragraphs 1 and 2) - concern was voiced about the exact meanings of several words and expressions, and alternatives were suggested. In particular, there were objections and

queries about the meanings of certain expressions, such as "international organizations", "under the auspices of", "for this purpose". Some delegates expressed the view that "to the extent feasible at this stage" be deleted, as it does not correspond with the clear reading of Article 247 of UNCLOS. With regard to the words "IOC internal procedures", it was agreed that these procedures would be applied only to the MSR projects undertaken by IOC or under its auspices.

<u>Clarity</u> (Paragraphs 2, 3 and general) – several suggestions were offered concerning a re-ordering or a re-drafting of portions of the text.

<u>**Consistency with UNCLOS**</u> (general) – there was general agreement that Article 247 is to be viewed jointly with other articles in Part XIII, in particular 248, 249, 253.

**Incompleteness of research proposals** (Paragraph 2) – there were objections to the prospects of incomplete project specifications.

<u>**Time limits**</u> (Paragraphs 2, 4 and 5) – the two-month time limit mentioned in the draft and specified in Article 11 of the IOC Rules of Procedure was considered by many delegates to be too short to permit proper analysis and evaluation of research proposals; on the other hand, it was pointed out that a State would in actuality have an additional four months to consider a proposal following its acceptance by the Assembly; a potential problem with seeking approval under Article 247 is that the IOC Assembly only occurs at two-year intervals, while not all Member States are represented at the IOC Executive Council, which meets every year.

<u>Procedures for non-Members States</u> (Paragraph 8) – the provisions were debated extensively; some delegates suggested that procedures were already well covered in Article 247 and in Paragraph 1 of the draft document, while others felt that specific procedures for non-Member States needed to be dealt with.

**Interpretation of the procedure** (Paragraph 10) – some delegates were of the view that these procedures should be interpreted in accordance with international law in general, and without exclusive reference to UNCLOS, to which some States were not party. Others expressed the view that these procedures should be interpreted strictly in accordance with UNCLOS. Another view was expressed that the interpretation of these procedures must not prejudice the rights, jurisdiction and duties of States under UNCLOS.

<u>**Communications**</u> (general) - there is uncertainty surrounding the "appropriate official channels" that are mentioned in Article 250, and through which communications on MSR projects must be directed to coastal States. Many delegates pointed out that such procedures should be handled through diplomatic channels.

**<u>Regional procedures</u>** (Paragraph 6) - it was agreed that this paragraph of the preliminary draft, which deals with MSR projects to be carried out within the EEZ and/or on the continental shelf of IOC Member States located within the geographical region of an IOC regional body, be deleted.

Some delegates expressed the view that document IOC/ABE-LOS II/8 offered useful basis for consideration and was clear and concise in approach.

It was noted that Article 247 has legal, technical, and political implications. It concerns the competencies of a coastal State in the maritime area under its jurisdiction. It is a component of the consent regime of Part XIII, and strives for a balance between the rights of the coastal State and the researching State.

In his summation, the IOC/ABE-LOS Chairman stated that there are two levels of difficulty in connection with the draft. The first level involves issues that can be easily overcome, such as time limits taking into account Articles 248, 249, and 253, and the formulation of a step-by-step approach. The second level consists of issues that are difficult to overcome, such as the wording of the title, the re-drafting and re-ordering of portions of the text, particularly Paragraphs 2 and 3. Procedures would have to address the timing of a proposal submission to the IOC, and the IOC's potential role in formulating, elaborating, and developing that proposal. The Chairman pointed out that a project has an identity only when it has been assigned a budget line.

The Chairman of the Sub-group expressed his appreciation for the comments and suggestions made and stated that he would carefully consider this feedback in preparing the next revision of the document. He will develop a new draft for study and discussion during the intersessional period.

#### 3.3 REPORT OF THE SECRETARIAT ON THE RESULTS OF THE IOC QUESTIONNAIRE 2 ON THE PRACTICES OF STATES IN THE FIELD OF MSR AND TMT, IN RELATION WITH ARTICLE 251 OF UNCLOS CONCERNING THE ESTABLISHMENT OF GENERAL CRITERIA AND GUIDELINES

Mr Roland Rogers opened the discussion of this report by explaining that he had been volunteered to assist the IOC Secretariat in the analysis of the completed questionnaire, and that he had worked closely in this undertaking with Ms Dienaba Beye under the direction of the Chairman of IOC/ABE-LOS. He thanked the delegates of Pakistan, the USA, and the UK for their comments, which had been subsumed into document IOC/ABE-LOSII/9, which also contains the Terms of Reference for the analysis. He acknowledged receipt of the very useful comments from the representative of UN/OLA/DOALOS, which had yet to be incorporated into the document.

Member States had worked hard to provide detailed information and he commended in particular the efforts made by the developing States. Document IOC/ABE-LOSII/9 is in the form of a scientific rather than legal paper. It contains four sections and four annexes.

Thirty-seven States had completed questionnaires, which were analysed over a period of one month. In his view the sample was of sufficient size to allow a sensible analysis to take place. The completed questionnaires contained information that falls into four distinct categories for purposes of analysis:

- 1. Yes/No responses
- 2. Statements of fact
- 3. Numerical data
- 4. Unsolicited but relevant comments not included in the report, but considered when formulating some of the issues in Section 4.

The document is not a final version but a draft, as envisaged for Stage 6-7 of the Work Plan contained in document IOC/ABE-LOSII/9.

The Chairman of IOC/ABE-LOS then invited delegates to comment on the draft report.

Many delegations commended the team effort made by the IOC Secretariat to produce the report on the results of the questionnaire. However, in considering the achievements and limitations of the work so far undertaken, it was pointed out that the study at present lacked, in particular, the following elements:

1. A complete questionnaire

- 2. Relevant sources of information
- 3. A sizeable sample
- 4. Objective and balanced questions

According to some delegations, the poor return rate could not justify the drawing of conclusions in Section 3, particularly since many respondents did not answer substantive questions and that in many cases, it had not even been possible to identify who were the respondents. Moreover, some of the questions were considered to lack compliance with the Convention and to infringe upon the discretionary powers of States. Additionally, some questions were considered confusing and based upon assumptions.

It was pointed out that the questionnaire included little mention of TMT. It was suggested that consideration should be given to rectifying this topic in future by developing a focused questionnaire on the issue.

It was also stated that the mandate for this questionnaire is contained in Recommendation 3 of Resolution XXI-2 of the 21<sup>st</sup> IOC Assembly. In this respect, the task was to compile and analyse the data and not to draw conclusions, which is the responsibility of IOC/ABE-LOS delegates.

Some delegates were of the view that the questionnaire constituted a good starting point. They pointed out that the questionnaire had stimulated efforts at gathering and discussing information at the national level, and that in some cases it had even fostered greater coordination between national bodies. Such delegates also considered that the gathered information was significant in view of UN experience. The results provided an informative overview of the situation with regard to State practices in MSR, and drew attention to some of the difficulties in relation to Part XIII of UNCLOS.

A query was raised concerning the questions relating to national legislation. It was mentioned that UN/OLA/DOALOS has the prime responsibility for maintaining a compilation of national legislation relating to the Law of the Sea. Delegates were encouraged to visit the new UN/OLA/DOALOS website on national legislation, where an improved search engine is being developed to support specialized queries. Other competent international organizations also have their own legislative databases, and it was in this regard that Question 1 on national legislation on MSR was included in the IOC second questionnaire. It was pointed out that a number of other national and international institutions maintain similar databases, and these should be taken into account in the drafting of future questionnaires.

The UN/OLA/DOALOS representative stated that the answers as received were meaningful. She pointed out that one effect of this questionnaire had been to prompt reaction and increase consciousness of MSR at the national level. She stated that this IOC second questionnaire was a preliminary step that it would require re-drafting, and that future work to this effect is undertaken largely by email.

It was generally agreed that the efforts made by Member States, and the work involved in the synthesis prepared by the Secretariat in IOC processing information in the second questionnaire had been a good initial exercise, and that the process should continue.

There was also general agreement that the existing questionnaire should be re-formulated by IOC with the assistance of IOC/ABE-LOS members through correspondence by email. To encourage greater response, it was agreed that future questionnaires should be simple and more focused. They should also address specific topics.

#### 4. FUTURE WORK OF THE IOC/ABE-LOS

There was a consensus that, in the near future, IOC/ABE-LOS should concentrate in finalising its work on the adopted three recommendations of Resolution XXI-2. Several points emerged from the discussion.

IOC/ABE-LOS is a unique international forum that consists of specialists working together in international law and marine sciences. Future work should therefore continue to focus on technojuridical issues. A possible area of involvement suggested by one delegation could be relating to Article 76, which has both legal and technical implications; any such work would be predicated upon a request originating from the IOC governing bodies, in consultation and cooperation with the Commission on the Limits of the Continent Shelf (CLCS) and IHO/IAG/IOC Advisory Board on the (Technical and Scientific Aspects of the) Law of the Sea (ABLOS). Other delegations, however, were unsure as to whether UNCLOS allowed for this kind of work for IOC/ABE-LOS.

It would be worthwhile also to consider developing relationships and close cooperation with other international institutions established by UNCLOS, such as International Seabed Authority (ISA), International Tribunal for the Law of the Sea (ITLOS), and CLCS. New scientific discoveries and technical developments such as the uniqueness of biological species in the vicinity of hydrothermal deep-sea vents, and the exploitation of resources of the deep seabed, are creating a rich environment for future cooperation between the scientific and legal communities. It was recalled that the ambassador Satya Nandan, Secretary-General of the International Seabed Authority, at the third meeting of the United Nations Informal Consultative Process on Ocean Affairs (ICP) held in New York in April 2002, raised the issue that UNCLOS does not adequately distinguish between the terms "marine scientific research", "prospecting" and "exploration", nor does it makes a distinction between "pure" and "applied" scientific research.

The Chairman also spoke in favour of IOC/ABE-LOS maintaining a watching brief on developments in the UN Informal Consultative Process (ICP) and the upcoming World Summit on Sustainable Development (WSSD) to be held in Johannesburg in August 2002.

#### 5. **RECOMMENDATIONS**

The IOC/ABE-LOS Group adopted the recommendations included in Annex II.

#### 6. ADOPTION OF THE REPORT

**The IOC/ABE-LOS Group decided** that the draft summary report of IOC/ABE-LOS II should be circulated to the group for comments. One delegation suggested that the names and countries of the intervening delegates be mentioned in the report. The Chairman pointed out that it had been the practice of IOC/ABE-LOS to refrain from identifying the names and countries of interveners unless expressly requested.

It was **agreed** that the second draft of the report will be circulated by 14 May 2002 by email to the IOC/ABE-LOS Group for comment, and that the deadline for feedback will be 22 May, in light of the fact that the Chairman of IOC/ABE-LOS will make an oral presentation of the report at the  $35^{\text{th}}$  session of the IOC Executive Council (Paris, 4 - 14 June 2002).

As a follow-up of an informal meeting between the IOC Executive Secretary and the African experts, a draft recommendation dealing with three primary topics was presented to the meeting:

- (i) the need to organize, in close co-operation with UN/OLA/DOALOS, sub-regional workshops and conferences on the Law of the Sea, in order to make better known the role of the IOC in relation to UNCLOS and to raise the awareness of decision-makers and stakeholders particularly on the strategic opportunities presented by the marine sector;
- (ii) the need to translate the scientific information imparted at conferences and workshops of the Law of the Sea into practical and concrete projects to be jointly identified and implemented in partnership with the relevant international organizations;
- (iii) the need for IOC assistance in the establishment of institutional frameworks at the national level that will be mandated to coordinate the marine affairs at the national, regional, and international levels. This assistance should be done in close co-operation with UN/OLA/DOALOS.

One delegate expressed the view that the above should be left to UN/OLA/DOALOS, and developed in co-operation with IOC. Another delegate suggested that these primary topics be submitted to the IOC Secretariat for possible consideration within the scope of Transfer of Marine Technology Guidelines, and be raised at the IOC governing bodies meeting(s) if deemed necessary. It was requested that these topics be included in the oral report of the Chairman of IOC/ABE-LOS at the forthcoming session of the IOC Executive Council, to be held in June 2002.

Recognizing that time and circumstances did not permit an opportunity for the presentation by the Chairman of the IOC/IHO/IAG Advisory Board on Technical Aspects of the Law of the Sea (ABLOS), the Executive Secretary of IOC requested the ABLOS report be distributed by email to all members as an accompaniment to the meeting report.

#### 7. CLOSURE

On behalf of the meeting, the Chairman thanked Professor Mohammed Moncef, IOC/ABE-LOS Representative for the Kingdom of Morocco and Chairman of the Local Organizing Committee, for the warm hospitality that had been provided. The delegates expressed their sincere thanks to the Chairman for the excellent leadership and guidance that he provided throughout the conduct of the meeting. They also expressed appreciation for the work done by the Secretariat.

The representative of UN/OLA/DOALOS announced that the United Nations is organizing a series of events to coincide with the 20th anniversary of UNCLOS in early December 2002. These will consist of ceremonies and round tables to review various aspects of the Convention. She invited members of IOC/ABE-LOS to consider participating in these events.

Finally, Professor Moncef read a message of thanks that will be sent to His Majesty King Mohammed VI on behalf of the meeting. The message is attached as Annex VI.

The second meeting of the IOC Advisory Body of Experts on the Law of the Sea was closed by the Chairman at 14. 05 p.m. Thursday 9 May 2002.

#### RECOMMENDATIONS

The IOC Advisory Body of Experts on the Law of the Sea at its second meeting (IOC/ABE-LOS II) recommended the following:

- 1) That the open-ended Sub-Group on Transfer of Marine Technology should continue its work by electronic correspondence, and in close co-operation with UN/OLA/DOALOS, on the elaboration of Criteria and Guidelines on the Transfer of Marine Technology (IOC/ABE-LOSII/7), with a view to their possible adoption by the 22<sup>nd</sup> Session of the IOC Assembly (2003). To this end, the Sub-Group should take Document IOC/ABE-LOSII/7 as a basis for its work, as well as the debate on such document at the Second meeting of IOC/ABE-LOS (IOC/ABE-LOS II).
- 2) That the open-ended Sub-Group on the IOC Internal Procedure related to an effective and appropriate use of Article 247 of UNCLOS on marine scientific research projects undertaken by or under the auspices of international organizations should continue its work by electronic correspondence, and in close co-operation with UN/OLA/DOALOS, with a view to its possible adoption by the 22<sup>nd</sup> Session of the IOC Assembly. To this end, the Sub-Group should take Document IOC/ABE-LOSII/8 as a basis for its work, as well as the debate on such document at the Second meeting of IOC/ABE-LOS (IOC/ABE-LOS II).
- 3) That the Secretariat should continue the collection and analysis of information from Member States on their practices in the field of marine scientific research and the transfer of marine technology, in close co-operation with UN/OLA/DOALOS. To this end, the IOC second questionnaire should be re-formulated in close co-operation with the IOC/ABE-LOS II Group, taking into account (i) the marine scientific regime as stated by UNCLOS, the development and transfer of marine technology and its related capacity building as stated by Part XIV of UNCLOS, (iii) as well as the debate on Document IOC/ABE-LOSII/9 at the Second meeting of IOC/ABE-LOS II).
